The vision of Torino goes beyond physical, economic and political boundaries reaching the whole world. How could it be otherwise? Historically the city was the driver of national unification and first capital of Italy, highly contributing during the 20<sup>th</sup> century to the industrial development of the country and showing over the years an unchanging lively spirit of enterprise. By its very nature Torino has always been open to changes and innovation, and ready to tackle the challenges posed by globalisation, thus confirming its leading international role in past and recent history.

Its increasingly important position as interlocutor on a range of regional and international issues allows the City of Torino to develop relations by organizing important events and networking with public and private institutions, associations, enterprises and other organisations. Its main goal is attracting a portfolio of investments to open new research centres and productive activities and to boost local economy.

This strategy gave rise in 2017 to the *Open for Business* programme, conceived together with Piedmont Agency for Investments, Piedmont Region, Unione Industriale, Chamber of Commerce, University and Politecnico of Torino, in order to foster the set up of new businesses and to attract foreign investments, in a city driven by research and innovation and already home to well established top-level production



activities in the aerospace, automotive, biomedical, telecommunication and food sectors. Tourism and culture, two of the key assets of our local economy, continue to strengthen the city's international image together with the high level academic offering provided by the University and the Politecnico of Torino, enrolling every year thousands of foreign students.

In 2017 the City of Torino carried out a large number of international activities, starting new forms of cooperation or confirming the already existing relations with international bodies and institutions: last spring it hosted the *Turin Islamic Economic Forum* and it organized several meetings, both locally and abroad, to promote local excellencies, share knowledge and exchange opportunities.

## FOCUS Torino - Chambéry: 60 years of friendship

Torino and Chambéry celebrated the 60<sup>th</sup> anniversary of their twinning organising a wealth of cultural events and leisure activities engaging citizens and local associations. Chambéry opened the celebrations in May with the conference *The Holy Shroud between Chambéry and Torino: history, mercy and devotion*, by Gian Maria Zaccone – Director of the International Centre of Sindonology, followed by the jazz concert by the *Icelfire Quartet* from Torino. The Chambéry City Hall also hosted the official ceremony attended by Mayor Dantin and Mayor Appendino while the city centre welcomed the parade of Italian and French vintage cars. Moreover, the U12 teams of Chambéry Savoie and Juventus F.C. played a friendly match.

In October, the City of Torino welcomed back its French counterpart with a successful programme of events: the presentation at the Royal Library of the unpublished manuscript by Jean Lenoir, on his journey from Novalesa to Torino in 1780-81; the readings on the Holy Shroud by Gian Maria Zaccone and the concert by the French chansonnier Marion Sila. The official agenda of the French delegation also included a meeting between the two Mayors at the City Hall and visits to Palazzo Madama, the Holy Shroud Museum and the Egyptian Museum. During the weekend the Savoy street market and the *Fanfare Etcetera* enlivened Piazza Palazzo di Città while a vintage car show - organised by Torino ASVA Club - was set in Piazza Vittorio.

## FOCUS TIEF

On 6<sup>th</sup> and 7<sup>th</sup> March Torino hosted the third edition of the *Turin Islamic Economic Forum*, focusing on the use of Islamic finance to trigger processes of social inclusion and foster internationalisation of local SMEs. The two-day event, characterised by ten sessions and by more than 50 speakers including public administrators, researchers, academics, businessmen and Islamic finance experts, was organised by the City of Torino together with Turismo Torino e Provincia, in partnership with the University of Torino, the Torino Chamber of Commerce and ASSAIF.

Moreover, as part of the *Torino Design of the City* event, the Torino Incontra conference centre hosted the seminar *Italian Islamic Heritage: twelve centuries of connections*, a journey through the Islamic historical-artistic-architectural heritage existing in Italy, to tell the intertwined stories linking Christianity and Islam, the West and the East through a series of engaging iconographies.

### 13 - 17 February Design for the Cities

Students coming from the Tiltan College of Haifa, the Tokyo Metropolitan University and the École de Condé of Paris attended the eighth edition of the *IAAD Turin Design Workshop* working together on design and its connection with society. Paola Pisano, Deputy Mayor for Innovation and Smart City Projects of the City of Torino, took part in the closing conference.

### 14 February Refugees, a documentary on Iraqi Kurdistan

On the occasion of the visit to Torino of the Mayor of Kirkuk, Ali Hassan Sardar, the Torino City Hall hosted the documentary film *Refugees* shot in Iraqi Kurdistan and witnessing life inside the Erbil refugee camp. The Mayor of Kirkuk and the Mayor of Torino Chiara Appendino were present at the screening.

### 6 - 7 April Open Innovation Summit

200 people coming from 12 countries and from 10 of the most innovative cities in the world, including Barcelona, Ankara, Washington and Boston, met in Torino to share successful practices of urban innovation and inclusive growth. Paola Pisano, Deputy Mayor for Innovation and Smart City Projects of the City of Torino and Claudio De Vincenti, Minister for Territorial Cohesion and the South, took part in the opening session.

### 2 May Clemantine Wamariya: story of a refugee

The City of Torino, together with the US Consulate General in Milan and Refugees Welcome Italy organized the public conference *Resilience, Courage and Determination*, Clemantine's experience as a Rwandan Genocide survivor and US refugee. The meeting was moderated by Marco Giusta, Deputy Mayor for Youth, Integration and Equalities.

### 17 - 21 May Torino-Rabat Festival of Friendship

The second edition of the festival celebrated the arts and literature of the Arab-Moroccan tradition with a series of meetings and lectures. Some of the conferences were carried out during the *International Book Fair*.

### 18 - 22 May 30<sup>th</sup> International Book Fair

Over 140 thousand visitors attended the 30<sup>th</sup> edition of the event dedicated to big authors and to Italian and international leading players on the cultural scene. The main theme of the fair was *Beyond the Border* and the United States were the guest country. Moreover, on 21<sup>st</sup> May, the International Affairs Department of the City of Torino organized the event *Torino beyond the borders* showcasing its Annual Report and some of its ongoing European projects.

### 19 - 21 May Catalunya experience in Torino

The Catalan Tourist Board and the Generalitat de Catalunya, under the patronage of the City of Torino, organized a packed programme of activities in the central Piazza Carlo Alberto: wine painting, show-cooking and the photo exhibition *Catalunya from the sky*, in addition to tourist information on the four Catalan provinces.

## Torino, Europeanist City

The San Pio V Institute in Rome, for the 60<sup>th</sup> anniversary of the Treaties of Rome and on the basis of the research *Europe of Municipalities*, awarded the City of Torino the title of Europeanist City for its pro-European vocation, resulting from the many events and European projects carried out so far. Mayor Chiara Appendino attended the award ceremony, held in the City Council Room.

7 - 8 June

## Changing skills for a changing world

More than 300 delegates coming from 28 ETF partner countries met at the Lingotto conference centre for the biennial international conference on the Torino Process, focusing on vocational education and training. Vice Mayor Guido Montanari took part in the opening ceremony.

22 - 23 June

## Urban Metabolism and Sustainability

The German Marshall Fund organized in Torino the Transatlantic Cities Lab entitled *Urban Metabolism and Sustainability: Exploring Climate Adaptation Strategies*, focusing on the policies carried out by Torino, Oakland and Portland to combat climate changes. At the end of the workshops the City of Torino hosted a public conference, attended by Deputy Mayor for Environment Alberto Unia.

## European Innovation Academy

600 students aged 18-28, coming from 40 countries worldwide, met at the Lingotto conference centre to develop ideas and technologies into start-ups. The City of Torino took part in the programme with 3 projects on open data and citizenship participation that the EIA students transformed from concepts into prototypes. Deputy Mayor for Innovation and Smart City Projects Paola Pisano attended the opening session.

## Sustainable mobility and European projects

In the framework of the European Mobility Week 2017 Villa della Tesoriera hosted the workshop *New mobility paradigms: Big Data, MaaS and SUMP* jointly organised by City of Torino, AIIT - Piemonte and Valle d'Aosta Section and the Engineering Council of the Province of Torino. The seminar focused on the major projects carried out by the City of Torino in the field of shared and sustainable mobility, in particular on the European projects SUITS, SUMP-UP, I-MOVE and SETA.

## Concert by Thierry Huillet and Clara Cernat

The famous French-Romanian duo performed an impressive concert at the Teatro Vittoria featuring two world premieres. The event was organized by the Villa of Composers with the support of the City of Torino and the Alliance française of Torino.

The event was organized by the Cities of Torino and Marseille in collaboration with the Chamber of Commerce of Torino, the Chamber of Commerce Marseille Provence and Provence Promotion.

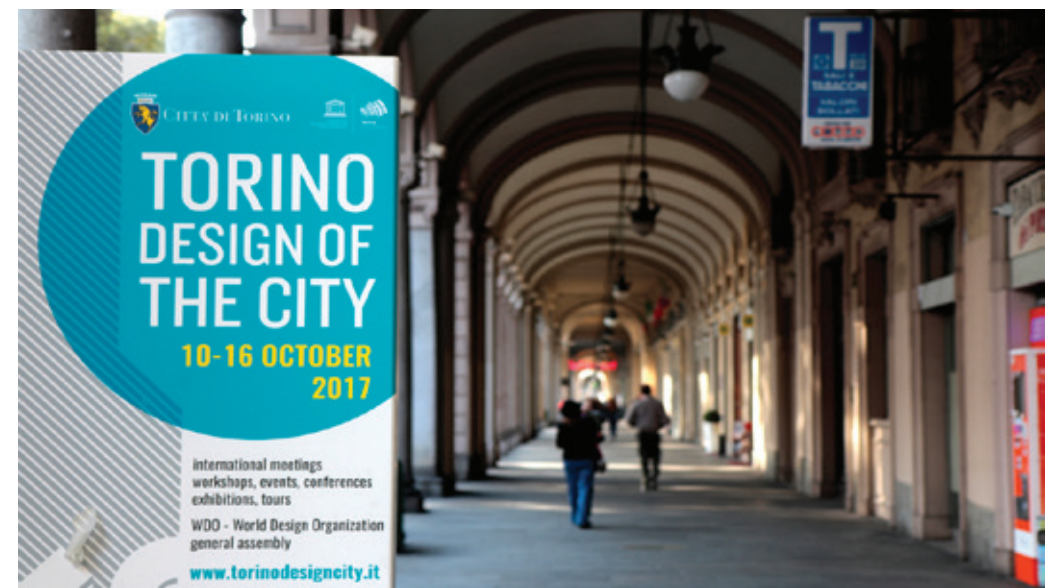
## Italian-Danish Forum on urban health

## BACAU – Romania

In 2007 the two Cities signed a Memorandum of Understanding in order to promote urban, social and cultural development and to support initiatives of integration addressed to the large Romanian community in Torino.

### Activities in 2017

- ▶ A delegation headed by the Chief of the municipal police of the Romanian city, Constantin-Florin Ener, met the leaders of the Torino local police to share know-how and methods of intervention.

## BARCELONA – Spain

In October 2005 a Memorandum of Understanding was signed to promote cooperation between the respective city markets, Porta Palazzo and La Boqueria. In December 2017 the two cities signed a cooperation agreement to strengthen their economic, cultural and academic relations with a special focus on technological innovation through the exchange of know-how.

### Activities in 2017

- ▶ Deputy Mayor for Innovation and Smart City Projects Paola Pisano took part as a speaker in the *Mobile World Congress 2017*.
- ▶ Representatives from the City of Barcelona attended the *Open Innovation Summit* held at the Open Incet.
- ▶ Participation of the City of Torino in the workshop *New approaches to urban goods deliveries on-street and off-street* of the NOVELOG project.

- ▶ Vice Mayor Guido Montanari headed a mission to Bethlehem for the final conference of the *BSW* project.

## BUENOS AIRES – Argentina

In 2010 the City of Torino and the Government of the Autonomous City of Buenos Aires signed a Cooperation Agreement based on art, culture, tourism and science dissemination. This agreement was renewed in 2013 by extending the areas of cooperation to economic development, mobility and transport.

## CAMPO GRANDE – Brazil

In 2003 a Cooperation Agreement was signed in the academic, cultural, social and economic fields.

## CANNES – France

Cannes and Torino, bound by historical cooperation relations, signed a Friendship Agreement in 2000, seeking to promote common projects on culture, sport and youth.

### Activities in 2017

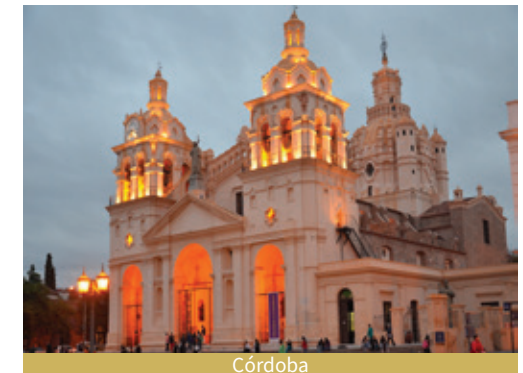

## CHAMBÉRY – France

Torino and Chambéry are bound by a historical twinning signed in 1957. In 2015 the two Cities signed a Letter of Intent to further support the several activities, exchanges and projects carried out every year in different fields.

### Activities in 2017

- ▶ Chambéry and Torino celebrated the 60<sup>th</sup> anniversary of their twinning with a wealth of events held in both cities.

- ▶ *La Parade Moderne*, itinerant sculptural performance devised by Clédât & Petitpierre, enlivened the streets of the city centre of Chambéry and Torino.

## COLOGNE – Germany

Twinning signed in 1958 to promote the path to European integration.

### Activities in 2017

- ▶ The Albertus Magnus Gymnasium of Cologne took part in *Languages on Stage!*, the European student festival of multilingual theatre, held at Casa Teatro Ragazzi e Giovani.

## CÓRDOBA – Argentina

Córdoba has historical relations with Torino due to Piedmontese emigration. The Twinning Agreement dates back to 1986 and on its 30<sup>th</sup> anniversary the two Cities signed a Letter of Intent.

### Activities in 2017

- ▶ A group of more than 40 engineering students came to Torino for study visits connected to the automotive sector.

## DETROIT – USA

The two Cities have been twinned since 1998. The agreement is aimed at strengthening relations by promoting cultural, social and economic exchanges.

### Activities in 2017

- ▶ The City of Torino attended the *Vibrant Neighbourhoods Forum* organized by the German Marshall Fund presenting the *CO-CITY* project.

## EKATERINBURG – The Russian Federation

The agreement was signed in 1998 in order to support and develop the cooperation between local management and economic institutions of both Cities.

## ESCH-SUR-ALZETTE – Luxembourg

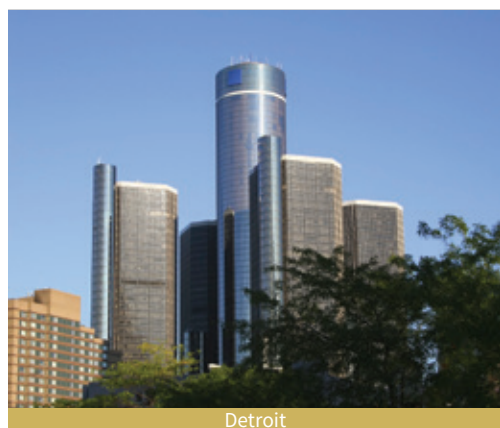
Twinning signed in 1958 to promote the path to European integration.

## GAZA – The Palestinian Territories

In 1996 the City of Torino committed itself to attempting a twinning with both an Israeli and a Palestinian city. Upon suggestion of the respective national authorities, Haifa and Gaza were chosen. The Twinning Agreement between Torino and Gaza was signed in 1999.

## GJAKOVA – Kosovo

Cooperation Pact signed in 2015 to promote economic, academic, cultural and e-government cooperation.

## GLASGOW – The United Kingdom

Between Glasgow and Torino, twin cities since 2003, exchanges are based on urban renewal, art and culture.

### Activities in 2017

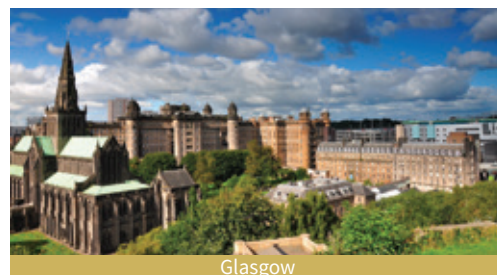

## HAIFA – Israel

In 1996 the City of Torino started a twinning process with both an Israeli and a Palestinian city, and Haifa and Gaza were chosen. A Memorandum of Understanding was signed with Haifa in September 2005.

- ▶ A delegation of students and professors from the Tiltan College of Haifa took part in the eighth edition of the *IAAD Turin Design Workshop*.

## HARBIN – China

The relations with Torino arose in the industrial field but were also extended to the two municipalities, which signed a Letter of Intent in 2003.

## HO CHI MINH – Vietnam

Friendship and Cooperation Agreement signed in September 2015 to foster exchanges in trade, academic, scientific, technological, cultural and environmental areas.

### Activities in 2017

- ▶ Vice Mayor Guido Montanari met a delegation led by the Vice Chairman of the People's Committee visiting Torino for institutional and technical meetings.

## KHARKHORIN – Mongolia

The City of Torino and the City of Kharkhorin signed in 2016 a Cooperation Pact to promote mutual activities in the field of tourism and culture, with historical, archaeological and inter-religious projects and training courses.

## KIRKUK – Iraq

Cooperation Pact signed in 2016 in order to promote mutual projects in the field of trade, culture and university.

### Activities in 2017

- ▶ Mayor Ali Hassan Sardar, leading a large trade delegation, met Mayor Chiara Appendino and representatives of the Torino Chamber of Commerce. During his visit, the Torino City Hall hosted the documentary film *Refugees* by the International Help Onlus organisation.

## LIÈGE – Belgium

Twinning signed in 1958 to promote the path to European integration. The activities focus on youth exchanges in the framework of European projects.

### Activities in 2017

- ▶ The City of Torino took part in the study visit programme carried out in Liège for the project *Beyond the Walls: models of integration*. A delegation from Liège subsequently visited Torino in the framework of the project, also meeting Mayor Appendino.

## LILLE – France

Twinning signed in 1958 to promote the path to European integration.

### Activities in 2017

- ▶ Vice Mayor Guido Montanari presented the major urban transformation processes underwent by Torino during a conference organized by the Lille Métropole Urban Agency and by GrandLille.
- ▶ The City of Torino attended the kick-off meeting of the European project *MOLOC* and took part in the event *Smart Cities in the Eurometropolis*.

## LUXOR – Egypt

Cooperation Pact signed in 2015 between the City of Torino and the Governorate of Luxor to promote mutual activities in economic, academic and cultural areas.



## LYON – France

In 2012 Torino and Lyon renewed the Cooperation Agreement signed in 2007, supporting the rich history of academic, cultural and economic relations.

### Activities in 2017

- ▶ The City of Torino took part in the *Fête des Lumières* festival, organized in the framework of the LUCI (Lighting Urban Community International) network.

## MAPUTO – Mozambique

The two Cities signed in 2015 a Cooperation Pact to promote projects on culture and tourism, trade, academic cooperation and environment.

- ▶ Participation of Torino in the 39<sup>th</sup> *Sister and Friendship Cities Children's Art Exhibition* with drawings made by students of the Leone Sinigaglia primary state school, and exchange of drawings with schools of Nagoya.

## NANTES – France

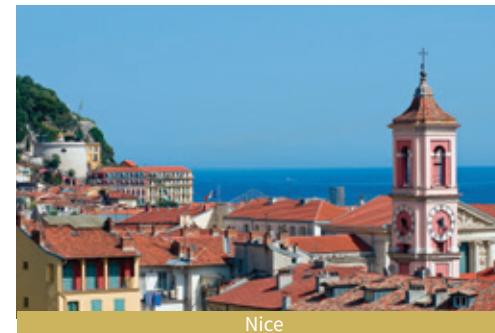
In 2013 Nantes and Torino signed a Letter of Intent to promote mutual cooperation on cultural and environmental issues.

- ▶ Deputy Mayor for Innovation and Smart City Projects Paola Pisano presented the *IoTorino* project during the exhibition *m-Tourism Day: Internet of Things for Tourism* in Nice.
- ▶ The Director of the Opéra of Nice, Eric Chevalier, met the Director of the Teatro Regio of Torino to discuss future cultural partnerships.

## PRAIA – Cabo Verde

In 2003 the Cities signed two Cooperation Agreements, a general one and a specific one for the Tira Chapeu district. The latter was supplemented in 2004 by a Protocol with ANCI – National Association of Italian Municipalities.

### Activities in 2017

- ▶ Representatives of the City of Torino attended the 4<sup>th</sup> *World Forum of Local Economic Development* in Praia.

## QUETZALTENANGO – Guatemala

The origin of this twinning, signed in 1997, goes back to 1991 when Torino awarded the honorary citizenship to the Nobel Peace Prize Rigoberta Menchú, to sustain the campaign against the discrimination of the Mayan people.

### Activities in 2017

- ▶ The Mayors of Torino and Quetzaltenango celebrated in live streaming the twentieth anniversary of the twinning, underlining the good relations and the several cooperation projects carried out throughout the years.

## ROSARIO – Argentina

In 2011 a Cooperation Protocol was signed, further strengthened in 2013 by a Letter of Intent aimed at supporting mutual cooperation on urban planning and development.

## ROTTERDAM – The Netherlands

Twinning signed in 1958 to promote the path to European integration.

### Activities in 2017

- ▶ A large delegation headed by the Alderman for urban development and integration met Vice Mayor Montanari. They also visited the Urban Center Metropolitano and were introduced to several models of urban transformation carried out in Torino.
- ▶ The City of Torino took part in Rotterdam in the *Innovative and Responsible Procurement's* partnership meeting held in the framework of the EU Urban Agenda.



## SAINT PETERSBURG – The Russian Federation

In 2012 the two Cities signed a multidisciplinary Cooperation Agreement. This agreement complemented the Protocol of Cooperation between the Fondazione Torino Musei and the Hermitage Museum signed to allow the exchange of collections.

### Activities in 2017

► Mayor Appendino and Deputy Mayor for Commerce, Labour and Tourism Alberto Sacco went on a mission to strengthen business ties. During their stay they held several institutional meetings.

## SALT LAKE CITY – USA

The twinning with Salt Lake City was signed in 2006, aimed at exchanging experiences and encouraging meetings between the two communities.

## SALVADOR DE BAHIA – Brazil

The historical presence of Piedmontese non-profit organisations in Salvador de Bahia led the two Cities to sign, in 2003, a Cooperation Agreement to be added to the twinning agreement between the Piedmont Region and the State of Bahia.

## SHENYANG – China

The twinning between Torino and Shenyang dates back to 1985. Over the years, several institutional meetings have strengthened the bond between the two Cities.

## SHENZHEN – China

In 2007 the two Cities signed an agreement called The Two Bulls.

## SKOPJE – The Former Yugoslav Republic of Macedonia

In 2012 the two Cities signed a multidisciplinary Cooperation Agreement.

### Activities in 2017

► Delegates from the City of Skopje took part

in the kick-off meeting of the *EUCANET* project held in Torino.

► During the contemporary arts month, representatives from Skopje made a study visit to Torino in the framework of the *ROCK* project.

## TIRANA – Albania

Cooperation Pact signed in 2016 to foster exchanges in the areas of trade, culture and university. The pact witnesses the long-established cooperation between the two cities, already confirmed by a Letter of Intent signed in 2009.

### Activities in 2017

► Representatives from Torino performed their works, together with 230 artists coming from 23 countries, at *Mediterranea 18*, the Biennale hosted in Tirana and Durrës and organized by the BJCEM network.

## TUNIS – Tunisia

In 2015 the two Cities signed a Cooperation Pact promoting relations in the field of trade, culture and urban development.

## YANGON – Myanmar

The signing of the Memorandum of Understanding in 2015 formalized the many ongoing activities of cooperation, including exchanges in the field of trade and services, tourism, social services, environment, local democracy, culture and art.

### Activities in 2017

► In the framework of the international cooperation project *SUMP*, Vice Mayor Guido Montanari was welcomed by the Mayor of Yangon and subsequently met in Torino a delegation headed by the Regional Minister Tin Aung Tun. Moreover, the City of Torino took part in the final conference of the project held in the Burmese city.

## ZLÍN – The Czech Republic

Agreement signed in 2004 to develop exchanges on cinema and audio-visual projects.

### 24 – 25 January Lyon

The City of Torino, represented by Deputy Mayor for Commerce, Labour and Tourism Alberto Sacco, together with Piedmont Region, Turismo Torino e Provincia and Piemonte Marketing, took part in the *Sirha*, world event for professionals in the catering and food industries. The delegation also attended the final of the *Bocuse d'Or*, internationally renowned contest of haute cuisine which Torino will host in 2018. Deputy Mayor Sacco also met the Deputy Mayor for Commerce of Lyon, Fouziya Bouzerda, the Vice President of Lyon Métropole for International Affairs and Attractiveness, Alain Galliano, and Mirco Iadarola, Secretary General of the Italian Chamber of Commerce in Lyon.

### 5 – 10 February Yangon

Vice Mayor Guido Montanari went to Yangon in the framework of *SUMP-Sustainable Urban Mobility Planning*, the international cooperation project developing activities aiming at planning and implementing better solutions on sustainable urban mobility. During his stay he met the Italian Ambassador Pier Giorgio Aliberti and the European Ambassador Roland Kobia, as well as the newly-elected Mayor of Yangon, Maung Maung Soe, the Prime Minister of the Regional Government of Yangon, Phyo Min Thein, and the Regional Minister of Transport, Nilar Kyaw.

Aim of the meetings was the development of new cooperation activities and common projects.

### 15 March Seville

She also met several Italian businessmen and academics on the occasion of the breakfast meeting organized by Business Club Italia.

### 5 – 6 July Nice

Paola Pisano, Deputy Mayor for Innovation and Smart City Projects, took part in the event *Smart Cities Live* lecturing on the vision of Torino with a speech entitled *Turin Becomes Intelligent. Turin Becomes Smart*. During her stay she also networked with representatives from the Cities of Barcelona, Dubai, Milan and Rome.

Deputy Mayor for Innovation and Smart City Projects Paola Pisano attended the *Mayor's Summit* organized in the context of the *Global Social Business Summit* in the framework of the *BoostInno* EU project. The City of Torino, together with Baia Mare, Barcelona, Braga, Milan, Paris, Skåne County, Strasbourg, Wrocław and Gdańsk, partners of the project, signed a Call for Action to continue the work already done on social innovation.

### 14 – 16 November Barcelona and Madrid

The City of Torino, represented by Deputy Mayor for Innovation and Smart City Projects Paola Pisano, took part in the *Smart City Expo World Congress* with a speech in the session entitled *Beyond the Smart City: Democratizing innovation while putting citizens first*. The Deputy Mayor's mission continued in Madrid where she attended the *Ciudades Democráticas* festival on participation technologies.

### 16 – 17 November Saint Petersburg

## Foreign delegations

Delegation of Chambéry

Several foreign delegations come every year to Torino, thanks to the various international relations that the City has established and to its cooperation with Consulates and Embassies. The meetings carried out promote a continuous exchange of experiences and are an opportunity to plan and develop cooperation agreements and projects.

In 2017 the City of Torino hosted 79 foreign delegations coming from 38 countries. It had the honour to welcome, among several foreign guests, some outstanding personalities: the Vice Chairman of the Ho Chi Minh City People's Committee, a delegation of the Commerce, Industry and Health Commission of the Finnish Parliament and the Mayors of Marseille and Taipei.

As a confirmation of the strong and fruitful relations established with friend and twin cities, Torino hosted on the occasion of institutional meetings Michel Dantin, Mayor of Chambéry, who took part with a large institutional delegation in the official celebrations for the 60<sup>th</sup> anniversary of the twinning with Torino; Takashi Kawamura, Mayor of Nagoya, Ali Sardar, Mayor of Kirkuk, as well as several representatives coming from the Cities of Córdoba, Glasgow, Lyon, Nice and Rotterdam.

Moreover, 23 Ambassadors and Consuls General coming from around the globe were received in the City Hall to plan common activities in the field of trade, culture, academic cooperation and tourism.

In 2017 Torino played host to many international events such as the third edition of *TIEF – Turin Islamic Economic Forum*, focusing on the use of Islamic finance to trigger processes of social inclusion and foster internationalisation of local SMEs; *Open Innovation Summit*, attended by 200 people coming from 12 countries and from 10 of the most innovative cities in the world who shared successful practices of urban innovation and inclusive growth; *Torino Design of the City*, a week of events focusing on design and on the effects it may have on the urban community.

### 100% YOUTH CITY

The City of Torino attended the partners meeting in Varna, Bulgaria, and the final ceremony of the project in Braga, Portugal. On that occasion it received the *100% Youth City Award* as local authority at the forefront of innovative and inclusive youth policies.

### BoostInno

Deputy Mayor for Innovation and Smart City Projects Paola Pisano represented the City of Torino at the *Global Social Business Summit* held in Paris; during the event, the project partners signed a Call for Action to continue the work on the development of technologies facilitating citizens' participation and boosting innovative solutions. In the framework of the project activities Torino also hosted *CLIMATHON*, the 24-hour hackathon on climate changes involving more than 112 cities in 44 countries. Torino attracted 100 participants, confirming its strong involvement in the issue.

### CESBA MED

The City of Torino, lead partner of the project, attended several meetings to actively work on the objective of developing energy efficiency plans to reduce the environmental impact of public buildings. In January it took part in the kick-off meeting hosted in Marseille and then it participated in the meeting held in Zagreb organized by the Energy Institute Hrvoje Požar and in the 3<sup>rd</sup> partners meeting held in Sant Cugat.

### Com'on Europe

The City of Torino participated, in the framework of the project funded by the Erasmus+ Programme and focusing on the creation of participatory budgets addressed to young people, in the kick-off meeting held in Cluj-Napoca, Romania, and in the follow-up meeting of Varna, Bulgaria.

### EUCANET

The City of Torino hosted the kick-off meeting of the project having as lead partner the Urban

Center Metropolitano. Besides technical meetings, a public event took place to debate on the project's main aim of creating a European network of Urban Agencies to enlarge civic involvement and commitment to the decision-making processes. The project partners also met in Marseille for the workshop *Consulting with Citizens in Large Scale Urban Repurposing* and in Bologna for the meeting focusing on *Urban Commons and the Cooperative City*.

### G3P Reloaded

The City of Torino, lead partner of the project, hosted the kick-off meeting officially launching the project's activities involving training of local police officials and exchange of good practices. The project was also announced to the Press during the ceremony for the 226<sup>th</sup> anniversary of foundation of the Local Police Force held at the Carignano Theatre.

### GOEASY

The City of Torino attended the kick-off meeting of the project held in Prague, home to the European Global Navigation Satellite System Agency. The project has as main objective leveraging the unique Galileo features to enable more secure and privacy-savvy mass-market applications of LBS.

### International Urban Cooperation – City to City

The City of Torino participated in the opening event of the International Urban Cooperation Programme held in Brussels at the European Commission. Torino was selected as partner of the Consorcio Intermunicipal Grande ABC (Brazil) for a one-year cooperation on the issue of sustainable mobility. In 2018, study visits will take place in Brazil and in Torino with mutual exchanges and learning activities.

### MOLOC

The City of Torino attended the kick-off meeting hosted by the City of Lille, lead partner of the project, to discuss urban planning measures and energy transition models. On the occasion

it also took part in the event *Smart Cities in the Eurometropolis*. Moreover, delegates from Torino attended the meetings held in Suceava and Hamburg.

## MONICA

Several activities were carried out over the year in the framework of the project, having the City of Torino as partner and pilot site with the *Kappa FuturFestival* and the *movida*. Delegates from Torino took part in the kick-off meeting held in Bonn and in the General Assembly held in Kingston, and the City of Torino welcomed the General Assembly attended by representatives of the 28 project partners, where Deputy Mayor for Innovation and Smart City Projects Paola Pisano gave a speech. Moreover, during the *Kappa FutureFestival* held in Torino in July, the first noise measurements were carried out in order to test the efficiency of wearables to monitor security situations and noise exposure.

## NOVELOG

Barcelona hosted the workshop entitled *New Approaches to urban goods deliveries on-street and off-street*. On that occasion the partners were presented with the AREADUM app developed by the Catalan city to manage urban goods deliveries and with the CityDepot initiative by the City of Brussels. The City of Torino welcomed in the City Hall the workshop on *Green Solutions for urban logistics* showcasing the Torino's pilot project on the use of public infrastructure for urban logistics. The workshop was opened by the keynote speech of Maria Lapietra, Deputy Mayor for Transport and Mobility.

## Beyond the walls: models of integration

The City of Torino together with some representatives of Piazza dei Mestieri, lead partner of the project, went to Liège, Lyon and Chambéry for onsite visits focusing on the models of integration of unaccompanied minors coming from third countries. The exchange of good practices mainly

included school inclusion, training and dual vocational training. In May, Torino hosted its foreign partners for a week of meetings and workshops working with local young people involved in the project.

## PRODIGE

SiTi – Higher Institute on Territorial Systems for Innovation hosted the final conference of the project having the City of Torino as one of its partners. During the meeting the final results were presented, with a focus on the Virtual Reality transboundary platform for the training of civil protection and emergency operators.

## RECOGNIZE AND CHANGE

Experts in the field of youth policies coming from Bulgaria, France, Greece, Portugal, Romania, Spain, Brazil and Cabo Verde met in Torino for the kick-off meeting of the project, having the City of Torino as lead partner. Deputy Mayor for Social Policies Sonia Schellino, Deputy Mayor for Youth, Integration and Equalities Marco Giusta, Deputy Mayor for Education Federica Patti and Deputy Mayor for Cultural Activities and Events Francesca Leon attended the different working sessions.

## ROCK

The City of Torino took part in Bologna in the kick-off meeting of the project as model city, together with Lyon, Liverpool, Vilnius, Cluj-Napoca, Athens and Eindhoven, in order to offer examples and solutions to the three replicator cities, i.e. Bologna, Lisbon and Skopje, so as to test new models of urban transformation and successful heritage-led regeneration initiatives. In November, representatives of EUROCITIES, ICLEI and from the Cities of Bologna, Lisbon, Skopje and Vilnius carried out study visits in Torino during the *Contemporary Art* week.

## SETA

In 2017 the implementation of the living labs connected to the project began. The City of Torino was involved with the following use cases: the smart video-surveillance systems

for public transport and traffic light control and two apps, the former addressed to business mobility managers to get commuting data on their employees and the latter addressed to freight transport users to help them searching for available load and unload parking areas.

## SocialCar

The project partners met in Brussels to discuss the innovative aspects of new models of data sharing for a better urban mobility in Europe and in Budapest and London for the General Meeting of the project. The Torino local team also presented the project during the event *Torino beyond the borders* organized by the International Affairs Department during the *Torino International Book Fair*.

## SOLEZ

The City of Torino hosted the partners meeting and study visit of the project funded by the Interreg CENTRAL EUROPE Programme having as main goal the reduction of traffic in functional urban areas.

## STEVE

Infineon Technologies Austria and the City of Villach hosted the kick-off meeting of the project, which aims to test electric mobility services in cities of different sizes and characteristics, using light electric quadricycles. The City of Torino participated in the meeting with a local technological cluster.

## SUITS

After the first working months, the project partners met in Thessaloniki to exchange experiences and technical know-how regarding data collection. Moreover, in December, the City of Torino hosted the project General Assembly.

## SUMP

Vice Mayor Montanari led a mission to Yangon in the framework of the international cooperation project aiming at strengthening the institutional relationship and at supporting Burmese local authorities in the development

and implementation of local policies on sustainable and participated urban mobility. The mission was followed by an exposure visit to Torino of a Burmese delegation, headed by Minister Tin Aung Tun, that also met Vice Mayor Guido Montanari and Deputy Mayor for Transport and Mobility Maria Lapietra. Yangon also hosted the project final conference, attended by representatives of the City of Torino, Cesvi, Ithaca and 5T.

## TRIVALENT

The conference *Europe and the challenges of radicalisation: what answers?*, held at the Italian Chamber of Deputies in Rome, officially opened the kick-off meeting of the project. The City of Torino took part in the two-day meeting on radicalisation and security.

## URBACT

The City of Torino attended the *Tallin URBACT City Festival*, the international event involving cities for mutual learning on urban development. The URBACT Programme labelled as URBACT good practices two projects developed by the City of Torino: the Areas of Commercial Coverage and InnoVA.TO.

## UrbanWINS

The Open Incet centre in Torino hosted the first Face-to-Face Agora of the project, where citizens were encouraged to discuss and plan concrete actions concerning waste management, resources and innovation. The City of Torino, together with other 7 European pilot cities, aims to identify new ways to increase recycling and economic models based on circular and sharing economy.

## MAECI projects

Moreover, Vice Mayor Guido Montanari led a delegation made up of Co.Co.Pa., SMAT, Ai Engineering and City of Torino taking part in the final conference of the project.

### P.I.E.R.MA.RKET

The City of Torino took part in a mission to Bethlehem to document the results of the

project, resulting in a bilingual documentary film presented during the 30<sup>th</sup> *International Book Fair* of Torino. The City's involvement in the project included technical assistance for the reorganization of the local wholesale market.

### INTERDISCIPLINARY TRAINING IN CONSERVATION OF CULTURAL HERITAGE

The City of Torino headed a mission for the beginning of the project, having as main goal the technical support to safeguard and promote an historical and cultural site in Bethany, in the outskirts of Jerusalem, identified as the tomb of Lazarus. Experts from the Conservation and Restoration Centre La Venaria Reale and lecturers from the University of Torino took part in the mission.

## ITC - ILO International Training Centre of the International Labour Organization

The International Labour Organization and the Italian Government founded the International Training Centre in Torino in 1964 as an institute of advanced vocational training.

The Centre actively works to strengthen capacities and expertise of governments, workers' and employers' organizations and other development actors in the field of labour, social justice and sustainable development. Every year it offers more than 450 programmes and projects to nearly 14,000 people from over 190 countries; from the beginning of its activity until today, more than 220,000 people have been trained at the Centre, in the regions or at a distance. The residential activities are held at the Torino Campus, built in 1961, and consisting of buildings arranged in five groups representing the continents of origin of the participants: Americas, Africa, Asia, Europe and Oceania. Cutting-edge teaching premises include a modern Conference Center for congresses, seminars, workshops and media events organized by the United Nations System and other institutions.

Since 2010 the Centre has established the Turin School of Development, a partnership with other UN agencies (UNESCO, WIPO, World Bank, UNCITRAL), the University and the Politecnico of Torino to offer postgraduate courses, gathering every year in Torino about 250 participants coming from all over the world.

## UNSSC United Nations System Staff College

The United Nations System Staff College, established by the UN General Assembly in 2002, is a centre of excellence for training and knowledge management within the UN System. Each year the learning initiatives offered by the Staff College including courses, workshops and conferences reach over 10,000 beneficiaries. Its learning programmes focus on those leadership and management skills needed to effectively serve as an international civil servant, as well as on thematic issues spanning the three pillars of the UN's work: peace and security, human rights and sustainable development. In particular, since 2015 all of the College's learning and training activities have been promoting change and innovation within the UN System in order to provide its staff with those specific skills that enable them to better address the challenges posed by the adoption of the 2030 Agenda for Sustainable Development.

## UNICRI United Nations Interregional Crime and Justice Research Institute

Established in 1965, UNICRI is an independent institute that addresses the needs of the international community formulating and implementing improved policies and actions in the field of justice and crime prevention. The Institute, based in Torino, coordinates specialized training activities addressed to participants from all over the world and has a liaison office in Rome and project offices in Algiers, Amman, Brussels, Geneva, Manila, Nairobi, Rabat, Tashkent and Tbilisi.

UNICRI produces research, policies, strategies and good practices; it delivers training activities, technical assistance and tools that contribute to enhance security, social cohesion and development; it promotes the exchange of expertise among countries, local

institutions, the scientific community, civil society and the private sector for the creation of platforms enabling the development of joint actions. Strengthening justice, preventing illicit trafficking and transnational organized crime, promoting assets recovery, mitigating the risks related to the improper use of new technologies and chemical, biological, radiological and nuclear materials, preventing violent extremism, counterfeiting, cyber crimes, hate crimes and crimes against the environment are among the Institute's current priorities. Trafficking in persons, gender-based drug prevention and treatment, tourism security and the improvement of prison systems are also issues addressed by UNICRI's programmes. Moreover, great attention is paid to the victims of crime, children and young people at risk.

In 2017 UNICRI continued its action to prevent and counter violent extremism in the Sahel-Maghreb region. Moreover, it enhanced its cooperation with a number of countries, including Indonesia, Jordan, Mali, Thailand, and Morocco, to support the design and implementation of tailored rehabilitation and reintegration programmes for violent extremist offenders in prison environments. In addition, the Institute assessed the pre-conditions for developing a juvenile diversion pilot programme for potential foreign terrorist fighters. In the framework of the *European Union Chemical, Biological, Radiological and Nuclear Centres of Excellence Risk Mitigation Initiative* (EU CBRN CoE), UNICRI carried out its action to strengthen the institutional capacities in the 57 partner countries involved. UNICRI developed the project *Strengthening Crime Prevention and Response in Tourism Destinations in Central America, Mexico and the Caribbean* and it worked with Tunisia, Libya, Egypt and the Camden Asset Recovery Inter-Agency Network in establishing new mechanisms to more effectively trace and recover illicit assets. In 2017 it signed an agreement for the establishment of the first United Nations Centre for Artificial Intelligence and Robotics and it developed an international network on biosecurity and bioethics.

The ETF, established in 1994, is a decentralised agency of the European Union based in Torino. It employs approximately 130 staff and its mission is to develop the EU external relation policies in 29 countries located in Eastern Europe, Central Asia and North Africa, promoting their political stability through the development of human capital. To meet its objective, the ETF supports its partner countries in the reform of education, training and labour market systems providing assistance and supporting the decision making processes towards a more inclusive social and economic development.

The ETF locally supports and plans events connected to training and employability. In 2017 it organized the conference *Changing Skills for a Changing World*, under the patronage of the City of Torino, which drew over 200 delegates coming from partner countries as well as EU member states for the exchange of good practices on vocational training. 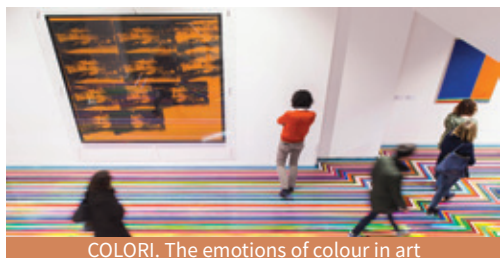


In 2017 the City of Torino offered an amazing line-up of activities, exhibitions, festivals and concerts involving the whole urban territory, from the city centre to the suburbs. Along with some already established successful events, part of Torino's cultural tradition, the 2017 programme was enriched by a host of new offerings. Torino thus confirmed its leading role on the international cultural scene, drawing an increasing number of foreign visitors as well as local citizens, who had the possibility to appreciate the cultural events held in town.

► **Palazzo Madama - Civic Museum of Ancient Art** hosted the exhibition *Objects from other worlds. Travellers' collections between the 19<sup>th</sup> and 20<sup>th</sup> centuries*, a journey across four continents with over 130 items donated by diplomats, businessmen, artists, traders and aristocrats.

► The exhibition *COLORI. The emotions of colour in art* was presented at the **GAM - Civic Gallery of Modern and Contemporary Art** and at the **Castle of Rivoli - Museum of Contemporary Art**. The extraordinary collection, with over 400 works by 130 artists from around the world, investigated the history, inventions, experience and use of colour in art.

► Some of the most important Italian and European museums lent their precious works to the **MAO - Museum of Oriental Art** to set up the exhibition *From the Ancient to the New Silk Road*, displaying 70 ancient objects witnessing the history of millenarian relationship between China and the West.

► The new **Egyptian Museum**, inaugurated in 2015, played host to several conferences with major international experts: *Small places - Big Issues: local life in ancient Egypt* by Richard Bussmann from the University of Cologne and *The Mechanics and Practice of Egyptian tomb robbery. A view from ancient Thebes* by Nigel Strudwick from the University of Cambridge, just to name a few.

► **Palazzo Chiabrese** displayed the outstanding exhibition *Miró! Dream and Colour*, dedicated to one of the greatest artists of the twentieth century, Joan Miró. The 130 works, almost all large-format oil paintings borrowed by the Fundació Pilar and Joan Miró in Majorca, included masterpieces such as *Femme au clair de lune* (1966), *Oiseaux* (1973) and *Femme dans la rue* (1973).

► The **Mastio della Cittadella** hosted the 150 prize-winning photographs of the most prestigious photojournalism contest in the world: the *World Press Photo*. The 2017 edition recorded the participation of over 80,000 photos made by 5,034 photographers and was a showcase of the most important events of our time through the images published in major international journals such as Time, Le Monde, The New York Times, The Guardian and National Geographic.

► The **PAV - Park of Living Art** presented the exhibition *The Extractive Machine. Neo-colonialisms and environmental resources*, an investigation into the antagonistic relationship between environmental activism and neo-liberal policies on a global scale through the works of Ursula Biemann, Oliver Ressler, Piero Gilardi, Peter Fend and Pedro Neves Marques.

► The **Fondazione Sandretto Re Rebaudengo** displayed *White Nights*, solo exhibition of the Japanese artist Hiroshi Sugimoto. The show included the international preview of a new photo series devoted to Italian historical theatres, an insight of his research on theatrical and cinematic spaces.

► The **Fondazione Merz** hosted the solo exhibition of the Cuban artist Carlos Garaicoa, *El Palacio de las Tres Historias*, an original project consisting of large-scale installations, photographic works and videos dedicated to the city as an ideal space for participation and development of stories and points of view, drawing its inspiration from the city of Torino.

► The **Pinacoteca Agnelli** continued its research project on collecting presenting, for the first time ever, an exhibition on archaeology: *THE HERO'S JOURNEY*, a collection of 522 Attic and Magna Graecia ceramics.

► The new **OGR - Officine Grandi Riparazioni**, an imposing late 19<sup>th</sup> century industrial complex, reopened following a huge project of radical refurbishment and conversion as hosting venue for the Creativity and Innovation District, meeting point for exhibitions, shows, concerts, theatre events, ballets, workshops, start-ups and innovative companies. The opening evening was animated by Giorgio Moroder, together with the Heritage Orchestra & the Ensemble Symphony Orchestra.

► The **National Cinema Museum** celebrated animals as main characters on the big screen with the exhibition *BESTIALE! Animals Film Stars*. Divided into ten different sections, the exhibit showed the multifaceted universe of animals through photographs, posters, stage costumes and special film sequence editing.

► The **National Automobile Museum** was part of the *Torino Design of the City* programme with its amazing exhibition areas and with a series of events specially organized for the occasion: *Open Day Open Garage* and the Italdesign *POPUP* show.

► *Titanic - The Artifact Exhibition*, hosted at the **Promotrice delle Belle Arti**, displayed for the first time in Italy original pieces of the famous ship: authentic objects belonging to passengers, finds and footage of that period depicting the dramatic story of the transatlantic liner sunk in 1912 after colliding with an iceberg.

► 206 galleries coming from 31 countries took part in **Artissima 24**, international fair of contemporary art, featuring *Disegni* - the new section devoted to the expressive medium of drawing and displaying the work of 26 artists and related galleries.

► In the week dedicated to contemporary art, Torino hosted **Flashback**, contemporary fair of ancient and modern art, in its fifth edition; **Dama**, independent project created by international



emerging art galleries; **Flat**, new international event dedicated to art publications and **Operae**, independent design fair.

► **Paratissima**, international showcase of emerging talents, was devoted to the theme of *Superstition*. For the first time ever, the fair was hosted in the La Marmora military barrack and brought together 536 artists, with 8 sections and 7 exhibitions overall.

► **The Others**, meeting point between art market and cultural innovation, gathered in its 7<sup>th</sup> edition 45 galleries, independent art spaces and curator collectives coming from Italy, Europe as well as the United States, Morocco and Japan.

► **Luci d'Artista** celebrated its 20<sup>th</sup> edition, in a perfect union of art and light from the city centre to the suburbs. The artworks collection, created by internationally renowned artists, was inaugurated with the lighting of *Once again*, made by the local artist Valerio Berruti with environmentally friendly materials and energy-efficient light sources.

► *Nature* was the main theme of the eleventh edition of **MITO SettembreMusica**, the international festival dedicated to classical music. Milan and Torino, over 19 days, hosted 140 concerts with original compositions, 10 Italian premieres and 7 world premieres, featuring some of the most important musicians on the international scene.

► The 2017 season of the **Teatro Regio** was characterized by 16 titles, 12 operas with 3 new productions and 3 magnificent ballet performances: *The nutcracker* in the fairy-tale setting by Amodio/Luzzati, *Swan Lake* by the Mariinsky Theater Ballet in St. Petersburg and the *Roberto Bolle and Friends* Gala. The season was further enriched by important international events that led the Orchestra and Choir of the Teatro Regio, directed by Gianandrea Noseda, on tour to Edinburgh, Gstaad, Muscat and Paris.

► The **Torinodanza Festival** provided a wealth of original art offerings with 24 shows, 28 performances, 9 Italian and world premieres, 4 co-productions and 15 companies coming from Burkina Faso, France, Germany, England, Italy, the Netherlands and Spain.

► The award-winning play *Disgraced* by Ayad Akhtar opened the **Teatro Stabile** season, which continued its international collaborations bringing to Torino, among others, *Les Trois Sœurs* by Anton Čechov, a co-production with Odéon - Théâtre de l'Europe under the direction of Simon Stone.

► The first edition of the **Narrazioni Jazz** festival offered to the whole city, over four days, a wide range of shows having as main theme the story-telling. The festival was characterised by the successful events *Jazz for the City 2017*, a vibrant cultural lab involving local major jazz artists and *Torino Jazz Night/Beyond the boundaries of night* that brought music and literature to squares, streets, concert halls and cafés.

► The **Festival delle Colline Torinesi - Torino Creazione Contemporanea**, in its 22<sup>nd</sup> edition, was devoted to women, witnesses of modern times, promoting the work of female authors, directors and actresses. Companies from Germany, Greece, Serbia, Somalia and Lebanon attended the event.

► In its tenth anniversary, the **Festival Teatro a Corte** was hosted in Torino and in the Savoy Residences of Aglié, Stupinigi and Venaria Reale. The 2017 edition was dedicated to France, the country that most contributed to the success of the festival, and offered an artistic path merging dance shows, theatre performances, contemporary circus, fireworks and new magic.

► **Torino Estate Reale**, in the picturesque setting of Piazzetta Reale, offered an extensive programme of shows, from symphony concerts to well-known songwriters, from classical ballet to contemporary flamenco, with artists coming, among the others, from Cuba, Spain and Morocco.

► **Languages on stage!** the European Student Festival of Plurilingual Theatre aiming to educate young people to European citizenship, knowledge and respect for different cultures through arts gathered in Torino students coming from Italy, Germany, France, Greece and Poland.

► The **Fondazione Teatro Ragazzi e Giovani** opened its new season having as main theme the *Storytelling*, a journey through celebrities, classic novels, life experiences, music, dance, mime performances, circus, theatre and magic shows featuring companies coming from Italy and France.

► **Incanti**, the international figure festival, in its 24<sup>th</sup> edition focused on the connection between music and puppetry hosting artists from Spain, Israel, Portugal, Germany, Ukraine and Italy.

► Over 140 thousand visitors attended the 30<sup>th</sup> edition of the **International Book Fair** having as main theme *Beyond the Border*. The International Book Forum area of the fair, created to facilitate networking between Italian and foreign publishers, hosted 600 operators coming from 31 different countries.

► The thirteenth edition of **Torino Spiritualità**, entitled *LITTLE ME*, engaged the audience in 30 different venues and 100 meetings with 120 speakers from all over the world. The five-day programme of dialogues, meetings and shows allowed a deep reflection on childhood and on its influences on adult life.

► **Biennale Democrazia**, in its fifth edition entitled *EMERGENCY EXITS*, focused on the crisis of our time, looking for the right answers but also for new ways and solutions.

► The 35<sup>th</sup> edition of the **Torino Film Festival** confirmed its international vocation hosting films and directors from all over the world, with over 63,000 attendees. The **TorinoFilmLab**, the international workshop supporting emerging film-makers and involving more than 120 professionals, celebrated its ninth edition.

► The 18<sup>th</sup> edition of **View Conference** presented a one-week programme of lectures, meetings, tributes, exhibits, screenings and demo presentations attended by leading experts in the fields of animation, visual effects, virtual reality, digital design and gaming.

▶ **Film Commission Torino Piemonte** supported the organisation of the 21<sup>st</sup> edition of *Cartoons on the Bay*, international cross-media and children's television festival. The event presented 531 works and hosted professionals coming from 53 countries.

▶ Over 30,000 people took part in the third edition of **Todays**, the festival exploring the many different art forms of our time. 40 hours of consecutive music in 3 days and over 80 artists and bands from around the world animated the event, held in regenerated urban spaces.

▶ **Club to Club**, international festival of avant-garde music and new pop, hosted over 87 artists from 11 countries in its 17<sup>th</sup> edition entitled *Cheek to Cheek*. 60,000 people attended the 51 performances played on 7 different stages.

▶ The sixth edition of **Kappa FuturFestival**, summer event of electronic music and digital arts, featured a line-up of music legends such as Fatboy Slim, Paul Kalkbrenner and Carl Cox.

▶ 4 stages, over 20 hours of non-stop music and a line-up of more than 50 international techno music DJs characterized the 12<sup>th</sup> edition of **Movement Torino Music Festival**.







## SPORT

**T**he City of Torino has long been committed to organizing sporting events at national and international level, in collaboration with federations, sports promotion bodies and associations. Torino has over 200 sport facilities including swimming pools, polyfunctional centres and gyms daily available to the thousands of people who practice sport, confirming the values of friendship, solidarity and fair play that the Torino 2006 Winter Olympic Games spread among citizens, athletes, volunteers and spectators.

As a confirmation of the leading role the Piedmontese capital plays on the international sporting scene, in 2017 the Universiade torch was lit in Torino and then travelled to Taipei, where the 29<sup>th</sup> summer edition of the Games took place. Starting from 2017, the torchlighting ceremony will be held under the Mole every two years, as a tribute to Torino, birthplace of the Universiade in 1959. Moreover, Torino won race to host the next *European Master Games*, scheduled from 26 July to 4 August 2019, after beating the candidate cities of Pesaro, Tampere and Kyrenia.



### 13 – 15 January ISU European Short Track Speed Skating Championships

Around 140 athletes, representing over 30 countries, competed for the European title at the Palavela rink. The Italian athlete Arianna Fontana and the Russian skater Semion Elistratov clinched the individual overall titles.

### 28 January Thai Boxe Mania

The best Italian and international fighters stepped into the ring for the eighth edition of the event on combat sports, in the thai boxing, muay thai, kick boxing and mixed martial arts disciplines.

### 11 – 12 February 34<sup>th</sup> International Regatta D'Inverno sul Po

The long distance rowing regatta, running along the river Po for 4 km, saw the participation of about 2,700 athletes coming from Italy, France, Germany, Switzerland and Greece.

### 27 February – 4 March Para Ice Hockey International Tournament

In the sixth edition of the international tournament of the Paralympic version of ice hockey, Canada, Norway, South Korea and Italy competed ahead of the 2017 World Championships. The Canadian team won gold.

### 18 – 19 March Judo Turin Cup

40 athletes from Italy, France, Poland and Russia took part in the prestigious international judo competition.

### 2 April Tutta Dritta foot race

The 15<sup>th</sup> edition of the running competition was attended by many international champions, who competed in the 10 km race running across the city.

### 8 April Oktagon

16 matches with 32 international top fighters and 4 world titles characterised the renowned international tournament of combat sports, in its 23<sup>rd</sup> edition, hosted in Torino for the second consecutive year.

### 22 – 23 April Torino 24-hour run

Torino hosted for the 9<sup>th</sup> year the international ultra marathon involving more than 200 athletes coming from all over Europe.

### 30 April – 1 May International Dancing Gold Master

The PalaRuffini arena hosted the annual international competition of Latin, standard and Caribbean dances. The best dancers from 15 countries, including Italy, Russia, France, Japan, Switzerland, Israel, South Africa and Spain took part in the contest.

### 5 – 7 May International Turin Curling Cup

36 teams coming from 8 different countries competed in the fifth edition of the Winter Olympics sport having its origins in Scotland.

### 27 May Thai Fight: King of Muay Thai

Torino hosted, for the first time in Italy, the most famous Thai sport event which saw the participation at the PalaRuffini arena of the best Muay Thai fighters in the world.

### 30 May EV Trophy - ecological Rally

Starting from Copenhagen and ending in Monte Carlo, the rally stopped in Torino to promote and support a more eco-friendly future for Europe.

### 10 June Rhythmic Gymnastics: Italy vs USA

The friendly match, characterised by a very high technical level, was won by the Italian butterflies.

### 10 June – 16 July Balon Mundial

41 national teams, including Gambia, Brazil, China and Mali, competed in the eleventh edition of the football world cup of migrant communities. The male tournament was won by Nigeria, the female one by Italy.

### 7 – 9 July Turin Acro Cup

Torino hosted for the fifth consecutive year the international event of acrobatic gymnastics with over 250 athletes representing 27 delegations coming from 10 countries.

### 8 – 15 July International Women's Tennis Tournament – MA-BO Trophy

The world-class event, in its tenth edition, was won by the Italian tennis player Deborah Chiesa who played the final match against the Mexican athlete Renata Zarazua.

### 3 September International Long-Distance Cycling Race

Torino was home, for the third consecutive year, to the cycling race hosting more than 1,700 athletes.

### 5 October Milano – Torino

In its 98<sup>th</sup> edition, the world's oldest cycling race registered the participation of 19 teams with the podium won by the Colombian athlete Rigoberto Urán.

### 6 October Football match: Italy vs Macedonia

The Grande Torino Olympic Stadium hosted the match between the Italian National team and the Macedonian one, valid for the 2018 FIFA World Cup Russia qualifiers. The match ended with the final result of 1-1.

### 21 October Torball International Tournament

The seventeenth edition was attended by 8 teams from Switzerland, France, Austria and Italy.

More than 1,000 athletes representing 23 nations took part in the 26<sup>th</sup> edition of the international regatta on the river Po.

**24 November**  
**Basket: Italy vs Romania**

The qualifying match for the 2019 Basketball World Cup China saw the Italian national basketball team competing against Romania, with a final result of 75-70 for Italy.

**1 – 3 December**  
**Foil World Gran Prix – Inalpi Trophy**

For the fourth consecutive year, Torino hosted the great international fencing with individual and teams competitions that involved 350 athletes from all over the world.

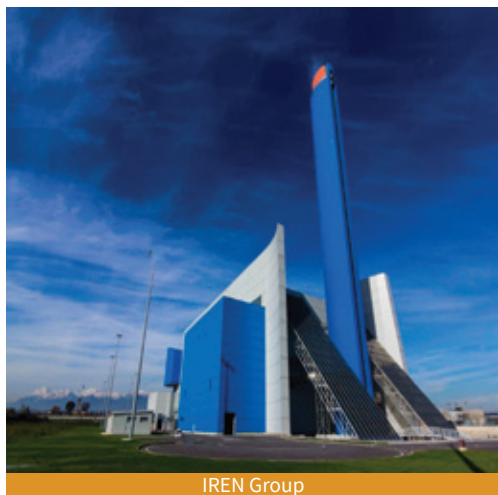


## Public utilities companies

### IREN GROUP

IREN Group, one of the main multiutilities in the Italian panorama, operates in the fields of electricity (production, distribution and sale), thermal energy for district heating (production and sale), gas (distribution and sale), management of integrated water services, environmental services (waste collection and disposal) and services for local governments.

The Group is also very active in terms of calls for innovation promoted at European level, which are being developed through a network of national and international partners. In 2017 IREN took part in 13 research and innovation projects for a total amount of 6 million euros, under the EU Programmes *Horizon 2020* and *VII Framework Programme*. The projects, actively involving about 50 employees, provide cooperation activities with business and academic centres in more than 94 European cities.

In particular, in the field of district heating and energy efficiency, the European projects *Flexmeter* and *CELSIUS* are underway while alternative energy sources are studied in the *EVERYWHERE* project. In the water sector *Reqpro* and *BlueSCities* ended in 2017, while *WaterSpy* is still underway and in the environmental field IREN is part of the *BioMethER* project. As regards electric mobility and on-road charging of vehicles, IREN participated in *FABRIC* and *NeMo*. The Group was also involved in the *STORE&GO*, *Pump Heat* and *Planet* projects for the analysis of the integration of different energy carrier networks and in the *Geosmartcity* project for the study of database interoperability addressed to underground users.

Moreover, IREN was awarded the 2017 Top Utility prize on Technology, Research & Innovation for its ability to develop cross-sector projects through open-innovation approaches.

### SMAT

SMAT Group manages the integrated water service of the City of Torino and other 291 municipalities of the Metropolitan City. The company is national leader in the areas of engineering, construction and management of diversified water sources, drinking water treatment plants, sanitation systems and recycling of urban waste water.

In 2017 SMAT continued its international activities with projects at European and non-European level. SMAT, through its Research Centre, carried on projects belonging to

the *Horizon 2020* Programme, in particular the *DEMOSOFC* project providing for the installation of the first industrial-scale SOFC (Solid Oxide Fuel Cell) plant for the production of electricity from biogas generated by waste water treatment in order to obtain clean energy. The partnership includes British and Finnish companies, as well as the Politecnico of Torino. SMAT also continued the implementation of the *BIOWYSE* project, foreseeing the development of kits for the instantaneous detection of the biocontamination level of water. The prototype, designed for use on the International Space Station, will allow astronauts to monitor in real time the microbiological quality of water intended for consumption, which is currently manually sampled to be sent to Earth and analysed after several months. Moreover, SMAT together with 15 leading European partners submitted the *5G Ensure - 5G Enablers for network and system security and resilience* project having as objective the assessment of 5G network efficiency and security.

SMAT also submitted, as lead partner, two further projects: *Biogas4Energy - Biogas Purification and conditioning from the anaerobic digestion of sludges coming from waste water*, aiming at developing a study

complementing the *DEMOSOFC* project, and *Hindeps - System for the detection of breaks in the water supply network through sound waves*. Outside Europe SMAT carried on the activities connected to the *Bethlehem Smart Water* project, aimed at planning and setting up a remote control system for the water supply network in the Palestinian cities of Bethlehem, Beit Jala and Beit Sahour. The project involves also staff training and is supported by the *Palestinian Municipalities Support Program*, by the Italian Consulate in Jerusalem, by the City of Torino, by Co.Co.Pa. and ATO3. It also continued to work on the *Safe Health and Water Management (Lebanon)* project, funded by ATO3 and having as partners the City of Torino, the Metropolitan City of Torino and Co.Co.Pa. managing Lebanese staff training. SMAT implemented the activities planned in the framework of the *PERSEO PERSONAL Radiation Shielding for IntErplanetary MissiOns* project, having as objective the assessment of the effectiveness of a wearable personal radiation protection system, to be used in a pressurized environment, to provide adequate shielding against Solar Particle Events (SPE) and to mitigate the effects of Galactic Cosmic Rays (GCR) on astronauts. In the field of international cooperation SMAT participated, as a partner, in the *Waste and Water Governance for sustainable urban sanitation - WaWa2Go* project, implemented in Ethiopia and having the Metropolitan City of Torino as lead partner. Finally, SMAT submitted the *Hebron Regional Wastewater Management* project that aims to help the Municipality of Hebron develop an integrated water system, improving the utility's management and maintenance services and planning training and information activities.

### GTT

GTT - Gruppo Torinese Trasporti - is a stock corporation wholly owned by the City of Torino through its subsidiary, FCT Holding S.r.l., with a total staff of about 4,800 employees.

GTT manages an underground automated line, 90 urban and suburban bus lines, 8 tram lines,



70 out-of-town bus lines and 2 railway lines, besides some parking areas and some tourist services such as the Sassi-Superga tramway and the panoramic elevator inside the Mole Antonelliana. Its transport services run from Torino to the provinces of Asti, Alessandria and Cuneo.

GTT was one of the first transport companies to get the *Recognised for excellence* award by the not-for-profit organisation EFQM - European Foundation for Quality Management. Moreover, it received the 2012 *Certiquality Award* for environmental innovation and it was certified to the OHSAS 18001 standard concerning occupational health and safety. Over the year GTT continued the international activities linked to the commercial agreement and promotional exchange signed with SNCF (French railways) in 2012.

## 5T

5T is the in-house providing company of the City of Torino, GTT - Gruppo Torinese Trasporti, Piedmont Region and Metropolitan City of Torino. It focuses on ITS solutions for integrated management of private and public mobility, offering expertise and services in the areas of traffic, infomobility, public transport and ticketing.

In 2017 5T enhanced its international relations hosting a high number of foreign delegations. In April, together with the City of Torino, 5T welcomed the *NOVELOG* partners and a delegation from the Commerce and Industry Commission of the Finnish Parliament. In May, it jointly organized with the Board of European Students of Technology of the Politecnico di Torino a training on Intelligent Transport Systems and a visit to the Mobility Headquarters for a group of foreign students coming from 23 countries. It also planned the last technical visit of the Yangon City Development Committee held in the framework of the *SUMP* project coordinated by the City of Torino with the technical support of 5T, CESVI and Ithaca.

Moreover, the City of Torino and 5T met a group of representatives from the US cities

of Portland and Oakland under the German Marshall Fund programme and a delegation from the City of Hanoi. Lastly, 5T met the partners of *SOLEZ*, the European project focusing on measures to support low emission zones in functional urban areas.

## SAGAT Airport

Torino Airport is one of the most important infrastructures in Piedmont, promoting economic activities and job creation in the region. Equipped with cutting-edge infrastructures, the airport offers more than 350 weekly scheduled flights, ensuring punctuality, security and comfort.

Daily connections with the main European and Mediterranean airports include Amsterdam, Barcelona, Brussels, Casablanca, Frankfurt, London Gatwick, Madrid, Monaco, Paris and Rome. Currently scheduled airlines serving the airport are Air Dolomiti, Air France, Air Moldova, Alitalia, Blue Air, Blu-Express, British Airways, Brussels Airlines, easyJet, KLM, Jet2.com, Iberia, Lufthansa, Luxair, Meridiana, Royal Air Maroc, Ryanair, S7 Airlines, Tarom, TUI fly, Turkish Airlines, Volotea, Vueling and Wizz Air. In 2017 Torino Airport inaugurated new direct international flights to Copenhagen, Lisbon, Malaga and Seville with Blue Air, Suceava with Tarom and Marrakech with TUI fly.

Scheduled flights from London Heathrow by British Airways, from St. Petersburg by S7 Airlines and from Birmingham by Jet2.com were opened for the incoming winter season. Moreover, new charter flights from Scandinavia increased the offer for the ski season.

In January-December 2017 Torino Airport reported record traffic growth: 4,176,556 passengers, with an increase in commercial and charter aviation of 5.8% compared to the previous year.

Torino Airport also continued to develop the non-aviation segment through an ever richer commercial offering, providing the terminal with new spaces and promoting high quality traditional local excellences. In 2017, the airport confirmed its partnership with *Artissima*

and with the National Cinema Museum, which advertised its temporary exhibitions in the Arrivals Area. SAGAT also established a new partnership with Thales Alenia Space, which displayed some of its most successful Space Programmes: IXV - Intermediate Experimental Vehicle, the European atmospheric return demonstrator, and ExoMars, the European exploration programme on Mars.

In the field of art, SAGAT made available to IGAV - Garuzzo Institute for Visual Arts some areas to exhibit the works of its artists. Furthermore, thanks to a new collaboration with CUS Torino - University Sports Center, passengers had the possibility to perform simple exercises through an interactive station in order to improve their well-being before and during the flight.

The *Airport Musical Season*, a series of concerts in the Departures Area, was organized as part of the partnership with the Teatro Regio of Torino. Moreover, during the *Movement* festival, the Departures Area was transformed into a jazz club for *La Stampa Sound Journey*, a

live electronic music performance entertaining passengers waiting for the take off.

On the occasion of the *International Book Fair*, the new BookCrossing station dedicated to passengers was inaugurated, giving them the pleasure of reading while waiting for their flight.

SAGAT contributes to the promotion of the territory as a tourist destination, in agreement with the carriers and in collaboration with Turismo Torino e Provincia and DMO Piemonte. This collaboration allowed to welcome a delegation from Seville, tour operators from Northern Europe, Canada, the United States as well as from the golf industry, journalists on an educational tour from St. Petersburg and to organize press trips for a group of influencers from Germany.

SAGAT also promoted local presentations in Seville in collaboration with Turismo Torino e Provincia and an event in Copenhagen with DMO Piemonte together with Blue Air for the promotion of direct flights from/to Torino.
